Applications received were scrutinized, and a tentative subject-wise roll order is released and is available at [www.nodalofficekdc.co.in](http://www.nodalofficekdc.co.in). The concerned applicants are advised to go through the list and check their tentative scores.

Nodal Office Kashmir Division through various channels such as official website, email, WhatsApp, print media (25th July 2024: Rising Kashmir, Daily Excelsior; 3rd August 2024: Rising Kashmir, Amar Ujala), etc provided ample opportunities to applicants to address deficiencies found in their applications. However, some applicants chose not to respond to the repeated opportunities. As such, these applications have not been included in the general roll order.

Further such applicants whose experience certificate/s have challenge of authenticity in terms of verification by issuing authority and are not figuring in the roll order can also represent in terms of contesting the evaluation of their experience certificates submitted online.

Representations regarding discrepancies in scores (if any) shall be entertained in online mode only, supported by documentary evidence. Such candidates having representations regarding discrepancies or absence of name in roll order are advised to log in to their dashboard at [www.nodalofficekdc.co.in](http://www.nodalofficekdc.co.in) and respond via the Verification/clarification-Query button only along with documentary evidence (in the form of a single PDF file to be uploaded), latest by August 12, 2024, up to 4:00 PM. No representation shall be entertained thereafter. Subsequently, final merit list shall be released.




